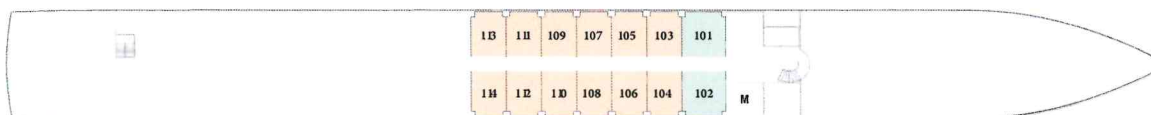
Diamond Deck
